Fighting Book Denials

If books or literature that were mailed to you were then denied by TDCJ, we recommend that you contest the denial.

According to a 1/31/10 article in the Austin American Statesman, book denials by mailrooms in TDCJ are reviewed by the Directors Review Committee. They are then usually turned over to two "program specialists" - Tammy Shelby and Jennifer Smith.

Pages cited by the mailroom as inappropriate are reviewed and then, if denied, the book goes on a banned book list PERMANENTLY (unless a policy change merits a review). This means that the book or literature will be denied to anyone else in the TDCJ that requests that book in the future. MANY BOOKS ARE BANNED SIMPLY BECAUSE THEY ARE NOT APPEALED, AND THEN THE BOOKS ARE PERMANENTLY BANNED THROUGHOUT THE TDCJ. We encourage you to contest your book or publication denials not only for your own benefit, but for the benefit of future inmates who may request the same title.

If you are in a Federal Unit in Texas, your book denial may be easier to challenge and prevent from being banned. According to Federal prison policy, "when a publication is found unacceptable...the warden shall permit the inmate an opportunity to review this material for purposes of filing an appeal."

Please consider the following when requesting books:

We accept one request per person once every three months. We track requests based on the postmark date of your request letter. For example, if you write on January 1st, we will not accept another request from you until April 1st. We will discard requests sent more frequently. Please understand that we enforce this policy due to our limited resources.

Please expect to wait 2-6 months for the delivery of your books based on our request backlog.

We welcome donation of stamps to help offset our postage costs. Please leave donated stamps loose, not attached to an envelope. We have a small library of donated books and may not have the exact title you are looking for. Our legal resources are particularly limited.

When requesting books, please let us know a range of books you're interested in so we can best fill your request.

When sending your request, always include your TDCJ number as well as your unit name and address. Please include information about guidelines and rules for receiving books for your unit.

We offer a Resource Guide (what you are reading now) with resources for prisoners. Inmates in Texas can receive a copy of this Resource Guide along with a request for books. Inmates outside of Texas are welcome to request only a Resource Guide by sending a request to the address in the "About this Resource Guide" section on the previous page.

If TDCJ denies one or all the books we send, you may contest the denial. See the "Fighting Book Denials" section on page 28.

We would love to receive your essays, articles, book reviews, fiction, poetry, letters, and artwork. We are always interested to hear about issues related to access to libraries, health care, and anything else that may be of concern to yourself or other prisoners.
