#### **Contesting Book Denials**

If books or literature mailed to you are denied by TDCJ, we recommend that you contest the denial. If a prisoner appeals a mailroom officer's decision to censor a publication, the appeal goes to the Directors Review Committee and/or

the Mail System Coordinators Panel in Huntsville. Pages cited by the mailroom as inappropriate are reviewed and if the book is denied, it takes a permanent place on the banned book list.

If the panel choose to censor the book, a mailroom official is responsible for notifying you and informing you of the appeals process. Many books are banned simply because they are not appealed, and this means the book will be denied to everyone else in the TDCJ. We encourage you to contest your publication denials, not only for your own sake but for other prisoners who may request the same title.

Book denials in a federal unit may be easier to challenge. According to Federal prison policy, "when a publication is found unacceptable ... the warden shall permit the prisoner an opportunity to review this material for purposes of filing an appeal.
