

Certification, job placement assistance, as well as case management.

## **VOTING RIGHTS**

## for people with criminal convictions

Felony disenfranchisement, i.e., the loss of voting and other civil rights, is an obstacle to participation in democratic life. This is exacerbated by racial disparities in the criminal justice system and creates a disproportionate impact on communities of color. Effective voting allows a community to determine its own destiny.

There are no longer any states with a lifetime voting ban, however, voting rights vary from state to state. In two states, Maine and Vermont, incarcerated people can vote in prison. In all other states, people in prison lose their voting rights all together.

In Wisconsin, voting rights for those with felony convictions are automatically restored as soon as you complete your sentence and are "off paper", i.e., off probation, parole, or extended supervision. However, you *must* register to vote even if you were registered before you were convicted of a felony. You do not need to provide any special documents, other than proof of residence, in order to *register*. To *vote* or request an absentee ballot you will need an acceptable photo ID. If you had a photo ID when you were incarcerated, you can ask the staff of the institution to make a copy of that ID for you, otherwise, you can an apply for a photo ID for free at any Wisconsin Department of Motor Vehicles; you will need documentation such as a birth certificate; proof of identity (such as a social security card) and proof of residence (such as a utility bill or DOC documentation from your probation/parole agents on a letterhead issued within the last 90 days).

If you are monitored by a "bracelet", or under a work-release program, you may need to get special permission to vote; ask your parole/probation officer about your status before you attempt to get documentation. If you were convicted of a misdemeanor, you retain your voting rights.
